# ORDER NO. 1 GRANTING MOTION TO SEVER AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses Quadvest LP's motion, filed on August 25, 2020, to sever the water certificate of convenience and necessity (CCN) amendment and sewer CCN amendment portions of its application, and Commission Staff's request for extension and amended procedural schedule, filed on October 15, 2020.

### I. Granting Motion to Sever and Restyling Docket

Quadvest requested to sever the application into two dockets, one addressing the requested water CCN amendment, and the other addressing the requested sewer CCN amendment. In support, Quadvest noted that the procedural and substantive prerequisites for approval are different for the requested water and sewer CCN amendments, and stated that Quadvest seeks to sever the application so that any delays incurred in one portion of the application do not cause delay in the resolution of the other portion of the application. Commission Staff did not oppose the motion to sever.

The administrative law judge (ALJ) grants the motion to sever the water and sewer portions of the application. Accordingly, Docket No. 50244 will address the requested water CCN

amendment and is restyled as reflected in the above caption. Docket No. 51431 is created to address the requested sewer CCN amendment, and is styled as reflected in the above caption.

For purposes of clarity and completeness, all items appearing in the Commission's Interchange under Docket No. 50244 as of the date of this Order are incorporated by reference into the administrative record of Docket No. 51431.

## II. Granting Extension and Amending Procedural Schedule

In Docket No. 50244, Commission Staff requested an extension of the deadline to provide final maps, certificates, and tariffs to Quadvest and requested that the remaining deadlines in the procedural schedule be adjusted accordingly.

The ALJ grants the requested extension and adopts the following procedural schedule in both Docket Nos. 50244 and 51431:
