### **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On November 15, 2019, Quadvest, L.P. (Quadvest) filed an application to amend its certificates of convenience and necessity (CCN) in Harris County. Quadvest holds water CCN number 11612 and sewer CCN number 20952. The requested service area consists of approximately 50 acres and has 0 current customers.

In Order No. 14 filed on February 3, 2021, the administrative law judge (ALJ) established a deadline of February 17, 2021 for Staff of the Public Utility Commission of Texas (Staff) to file a supplemental recommendation addressing regionalization, consolidation, effects on adjacent utilities, if any, and whether Quadvest has complied with 16 Texas Administrative Code (TAC) § 24.227(b)(3), (4). Therefore, this pleading is timely filed.

#### **I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to review the information submitted by Quadvest. Accordingly, Staff requests that its deadline to file a response to the request for clarification be extended to March 10, 2021.

#### **II. CONCLUSION**

Staff respectfully requests the issuance of an order extending the deadline for Staff to file a response to Order No. 14 to March 10, 2021.
