CSWR-TEXAS UTILITY OPERATING COMPANY, LLC'S **DESIGNATION OF PROTECTED MATERIALS**

Pursuant to the protective order entered in this proceeding, CSWR-Texas Utility Operating Company, LLC ("CSWR Texas") is designating certain confidential material provided in response to Staff's first set of Requests for Information. The undersigned counsel for CSWR Texas has reviewed the information sufficiently to state in good faith that the information is exempt from public disclosure under the Public Information Act and merits the Protected Materials designation.

CSWR's attachments to Staff 3-1 and 3-2 contain commercially sensitive financial and business operation information. The public disclosure of the information would cause substantial competitive harm to CSWR, LLC and its subsidiaries, including CSWR Texas. Any other entity that seeks to acquire water utilities in Texas and elsewhere could use the financial information to its competitive advantage, to the detriment of CSWR, LLC and its subsidiaries. Accordingly, the information contained in Staff 3-1 and 3-2 is exempt from public disclosure under Tex. Gov't Code §§ 552.101, 552.104 and 552.110.
