TO THE PUBLIC UTILITY COMMISSION OF TEXAS:


COMES NOW, Clay Road 628 Development, LP (Clay Road or Petitioner) and Stanley Lake Municipal Utility District (Stanley Lake MUD) and files this their Joint Filing regarding Compensation in Petitioner's Petition for expedited release from water certificate of convenience and necessity No. 11222 and sewer certificate of convenience and necessity (CCN) No. 20483, pursuant to Texas Water Code § 13.2541 and 16 Tex. Admin. Code § 24.245(i)(1).

Clay Road and Stanley Lake MUD have agreed that the compensation for the decertification Stanley Lake MUD's CCNs overlapping the Clay Road property should be \$0.00 plus other good and valuable consideration related to the completion and review of a survey of the area. Additionally, such compensation has already been paid by Clay Road to Stanley Lake MUD, and by this filing, Stanley Lake MUD acknowledges its receipt.


Clay Road and Stanley Lake MUD respectfully request that the PUC, through an informal disposition proceeding under 16 Tex. Admin. Code § 22.35(a), issue an order regarding the compensation to Stanley Lake MUD and acknowledge that such compensation has already been paid by Clay Road.


