CSWR-Texas Utility Operating Company, LLC ("CSWR Texas" or the "Company") submits this First Supplement to its Application pursuant to discussions with Commission Staff. The Company is providing the additional financial information requested by Commission Staff (Highly Sensitive Attachment A); the affidavit of Josiah Cox attesting to CSWR Texas' financial capability (Confidential Attachment B); and correspondence between CSWR Texas and the Texas Commission on Environmental Quality ("TCEQ") showing the Company is working with the TCEQ towards a compliance agreement to allow the Company time to address any outstanding compliance issues identified by the TCEQ once the sale is complete (Confidential Attachment C).

The Company is providing this information confidentially because it contains competitively sensitive business operations and financial information as well as transactional information related to other water or wastewater systems that have not been made public, and this information is exempt from public disclosure under Tex. Gov't Code §§ 552.101, 552.104 and 552.110. The undersigned counsel for CSWR Texas has reviewed the information sufficiently to state in good faith that the information is exempt from public disclosure under the Public disclosure under the Public Information Act and merits treatment as confidential or highly sensitive materials.
