AGREED REQUEST FOR EXTENSION

SWWC Utilities, Inc. d/b/a Water Services, Inc. (Water Services) and Monarch Utilities I L.P. (Monarch) (collectively, Applicants) files this Agreed Request for Extension and would respectfully show the following:

I. BACKGROUND

On February 9, 2021, the Commission issued Order No. 10,¹ establishing February 25, 2021 as the date by which the Staff of the Public Utility Commission of Texas (Commission Staff) would provide final maps, certificates, and tariffs (if applicable) to Applicants for review and consent. Order No. 10 further established March 11, 2021 as the deadline for Applicants to file consent forms with the Commission.

II. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code § 22.4(b), Applicants request a new deadline of March 25, 2021, for Commission Staff to provide final maps, certificates, and tariffs (if applicable) to Applicants for review and consent, and for Applicants to file consent forms—as described in Order No. 10—to April 1, 2021, to allow time for the parties to continue discussions regarding the tariff provided by Staff on February 25, 2021. The parties are working diligently to prepare the required documents and need additional time to finalize them in light of Monarch’s pending rate

case in Docket No. 50944. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. Applicants conferred with Commission Staff, and they have agreed to Applicants' request.

III. CONCLUSION

Applicants respectfully request the issuance of an order granting Applicants' request extending the deadline for Applicants to file consent forms with the Commission to April 1, 2021.
