**AGREED REQUEST FOR EXTENSION**

On December 5, 2019, SWWC Utilities, Inc. d/b/a Water Services, Inc. (Water Services) and Monarch Utilities I, L.P. (Monarch) (collectively, Applicants) filed an application with the Public Utility Commission of Texas (Commission) for approval of the sale, transfer, or merger of facilities and certificate rights in in Bandera, Bexar, Comal, Gillespie, Guadalupe, Hays, Kendall, Kerr, and Medina Counties.

On March 12, 2021, Order No. 11 in this proceeding was filed, requiring the parties to file joint proposed findings of fact and conclusions of law by April 15, 2021. Therefore, this pleading is timely filed.

**I. AGREED REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), the parties may request that the time allowed for filing any documents be extended for good cause. The parties are in contact and working together to compile a joint motion to admit evidence and proposed notice of approval. In order to allow time for the parties to continue working together on the filing, the parties respectfully request that the deadline to file joint proposed findings of fact and conclusions of law be extended until April 22, 2021.
