## AGREED REQUEST FOR EXTENSION

On December 5, 2019, SWWC Utilities, Inc. d/b/a Water Services, Inc. (Water Services) and Monarch Utilities I, L.P. (Monarch) (collectively, Applicants) filed an application with the Public Utility Commission of Texas (Commission) for approval of the sale, transfer, or merger of facilities and certificate rights in in Bandera, Bexar, Comal, Gillespie, Guadalupe, Hays, Kendall, Kerr, and Medina Counties.

On April 14, 2021, Order No. 12 in this proceeding was filed, requiring the parties to file joint proposed findings of fact and conclusions of law by April 22, 2021. Therefore, this pleading is timely filed.

### I. AGREED REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), the parties may request that the time allowed for filing any documents be extended for good cause. The parties are in contact and working together to compile a joint motion to admit evidence and proposed notice of approval. The parties note that the tariffed rates in this docket are associated with the interim rates effective in Docket No. 50944, in which the parties are working together to resolve a minor issue with the interim rates tariff. In order to allow time for the parties to resolve the associated issue in Docket No. 50944 and update the relevant documents in this docket, the parties respectfully request that the deadline to file joint proposed findings of fact and conclusions of law be extended until April 29, 2021.
