## COMMISSION STAFF'S REQUEST FOR EXTENSION

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this request. In support thereof, Staff would show the following:

#### I. BACKGROUND

On December 6, 2019, County Line Special Utility District (County Line) filed an application for a sewer certificate of convenience and necessity in Hays and Caldwell counties pursuant to Texas Water Code (TWC) §§ 13.242–250 and 16 Texas Administrative Code (TAC) §§ 24.225–.237. The requested area consists of approximately 17,942 acres, 2 existing connections, and 24,100 future connections.

On March 18, 2020, Order No. 3 was issued, finding the application administratively complete. On April 27, 2020, Order No. 4 was issued, finding notice sufficient and requiring Staff to file its final recommendation by July 24, 2020. This pleading, therefore, is timely filed.

### II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional documentation from County Line regarding requests for service for the requested area. At present, it appears County Line has documented requests for service for approximately 6,235 acres of the requested 17,942 acres. As such, Staff requests that the deadline to file its final recommendation be extended to August 24, 2020.

#### III. CONCLUSION

Staff respectfully requests the issuance of an order consistent with the foregoing request.
