## APPLICATION OF COUNTY LINE SPECIAL UTILITY DISTRICT TO OBTAIN A SEWER CERTIFICATE OF CONVENIENCE AND NECESSITY IN HAYS AND CALDWELL COUNTY

#### AGREED REQUEST FOR EXTENSION

On December 6, 2019, County Line Special Utility District (County Line) filed an application for a sewer certificate of convenience and necessity in Hays and Caldwell counties under Texas Water Code §§ 13.242–.250 and 16 Texas Administrative Code (TAC) §§ 24.225–.237. The requested area consists of approximately 17,942 acres, 2 existing connections, and 24,100 future connections.

On March 23, 2021, Order No. 10 was filed, requiring the Staff of the Public Utility Commission of Texas (Staff) and County Line to file briefings as to whether they are currently in agreement regarding the proposed service area for this docket or to request a hearing by April 20, 2021. This pleading, therefore, is timely filed.

#### I. **REQUEST FOR EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff and County Line are continuing to negotiate to see if an agreement can be reached regarding the proposed service area and are discussing the timing of the acquisition of the appropriate wastewater permits for service. As such, Staff requests that the deadline to file briefing or request a hearing be extended to June 18, 2021.<sup>1</sup> Staff has conferred with County Line on this request, and County Line supports the request.

### II. CONCLUSION

Staff respectfully requests the issuance of an order consistent with the foregoing request.
