**COMMISSION STAFF’S REQUEST FOR EXTENSION**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for Extension. In support thereof, Staff shows the following:

**I. BACKGROUND**

On December 6, 2019, Gristmill Utility Company, LLC (Gristmill) filed an application for a sewer certificate of convenience and necessity (CCN) in Hays County. The requested service area consists of 260 acres, and 888 current customer connections.

On August 17, 2020, Order No. 7 was issued setting a deadline of October 9, 2020, for Staff to file a recommendation on the sufficiency of notice. Therefore, this pleading is timely filed.

**II. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has discovered that customers in Gristmill’s requested service area have not been properly noticed. Staff and Gristmill are working in concert to ensure that proper notice is provided to all affected customers in Gristmill’s requested service area but requires additional time. Therefore, Staff requests an extension until October 23, 2020 to file a recommendation on the sufficiency of notice.

**III. CONCLUSION**

Staff respectfully recommends an order consistent with the foregoing request.
