IT IS ORDERED that the Administrative Law Judge (ALJ) will convene a hearing via Zoom videoconferencing platform on March 9, 2021, at 9:00 a.m. The ALJ will make an audio

recording of the hearing, and it will be the official record of the proceeding. Prior to the hearing,

the parties must provide to witnesses all documents necessary for their effective participation in

the hearing. Parties should also speak to the witnesses they intend to call to testify and provide

them the necessary videoconferencing information. Participants using portable devices should

ensure they have sufficient charge and/or a power source readily available.
