## ORDER NO. 2 FINDING APPLICATION ADMINISTRATIVELY COMPLETE; NO FURTHER NOTICE REQUIRED; AND ESTABLISHING A PROCEDURAL SCHEDULE

This Order addresses the notice requirements and administrative completeness of the application filed on December 20, 2019, by SJWTX, Inc. dba Canyon Lake Water Service Company, Aqua Texas, Inc., and Aqua Development, Inc. (collectively, applicants) for approval of a service area contract under Texas Water Code § 13.248, and to amend certificates of convenience and necessity in Comal County.

Commission Staff indicated in its recommendation filed on January 31, 2020, that the notice requirements in 16 Texas Administrative Code (TAC) § 24.253(c) are not applicable and notice of the application is not required because there are no facilities or current customers in the service areas to be transferred and all three of the applicants are investor-owned utilities.

The ALJ finds that no further notice is required and that the application is sufficient. The following procedural schedule applies:
