## COMMISSION STAFF'S REQUEST FOR AMENDED PROCEDURAL SCHEDULE

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for Amended Procedural Schedule. In support, Staff would show the following:

#### I. BACKGROUND

On December 20, 2019, SJWTX, Inc. dba Canyon Lake Water Service Company (CLWSC), Aqua Texas, Inc. (Aqua), and Aqua Development, Inc. (Aqua Development) (collectively, Applicants) filed an application for approval of a service area contract under Texas Water Code (TWC) § 13.248 and to amend water and sewer Certificates of Convenience and Necessity (CCNs) in Comal County, Texas.

Order No. 2, issued February 3, 2020, adopted a procedural schedule, which established April 30, 2020 as the deadline for Staff to provide final maps, certificates and tariffs to the Applicants.

#### II. AMENDED PROCEDURAL SCHEDULE

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff respectfully requests that the procedural schedule be amended as follows to allow time for Staff to complete its preparation of final maps, certificates, and tariffs for Applicants' review:

Event	Date
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable) to applicants for review and consent	May 21, 2020
Deadline for applicants to file signed consent forms with the Commission	June 4, 2020
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	June 11, 2020
If no hearing is requested, deadline for parties to jointly file proposed findings of fact and conclusions of law	June 18, 2020

## III. CONCLUSION

For the reasons discussed above, Staff respectfully requests that the administrative law judge amend the procedural schedule as proposed above.
