

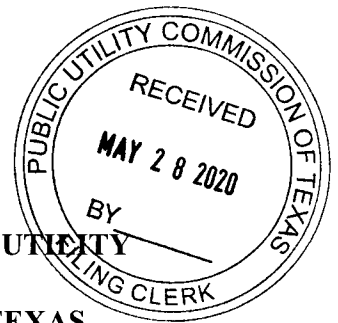

**APPLICANTS' SUPPLEMENTAL APPLICATION INFORMATION RELATED TO
MINOR TARIFF CHANGES REQUIRED BY APPLICATION**

COME NOW SJWTX, Inc. d/b/a Canyon Lake Water Service Company ("CLWSC") and Aqua Development, Inc. and Aqua Texas, Inc. ("Aqua") (collectively, "Applicants") and file this Supplemental Application Information Related to Minor Tariff Changes Required by Application. In support, Applicants would show as follows.

The result of this application will require certain minor tariff changes to the Applicants' water and sewer utility tariffs to maintain compliance with Commission rules.¹ Commission Staff has requested that Applicants make this filing to explain those changes so that Commission Staff may prepare revised tariff documents for Applicants' review and consent along with map and certificate documents that implement the Applicants' Texas Water Code (TWC) §13.248 contract.

The water and sewer CCN areas to be transferred from Aqua to CLWSC are shown in the Applicants' contract, included as Exhibit 1 to the application, in contract Exhibits B-1, B-2, D-1, and D-2. The water CCN area to be transferred from CLWSC to Aqua is shown in contract Exhibits A and C.

CLWSC currently does not have a system or subdivision name referenced in its water utility tariff for the undeveloped water CCN area the Applicants have agreed to transfer to Aqua Texas, Inc. CLWSC currently has a reference for “Rebecca Creek” in its water tariff now applicable to adjacent certificated CLWSC water service territory, but which CLWSC also plans to use as its reference for the water service area CLWSC will receive from Aqua. In contrast, CLWSC has no reference to “Rebecca Creek” in its sewer utility tariff. Therefore, the only minor tariff change CLWSC will need approved as part of this application is the addition of “Rebecca Creek” as a subdivision and service area to its sewer tariff without a specified permit number (which will be determined at a later date).


Aqua has recently worked with Staff to finalize its Southwest Region water and sewer utility tariffs resulting from Docket No. 48769² and Tariff Control No. 50573.³ Aqua understands the final decision here is expected to follow final decisions, which Aqua hopes are approvals, in those two Aqua matters. But, following what Aqua also hopes is an approval here, certain minor tariff changes will be required. First, Applicants have agreed to transfer a single water CCN area from CLWSC to Aqua, and, as described previously, to transfer water and sewer CCN areas from Aqua to CLWSC. The water and sewer CCN areas to be transferred from Aqua to CLWSC are currently reflected in references to “Rebecca Creek (Comal County)” in the paragraph below system list Table A in Aqua’s anticipated Southwest Region water utility tariff and in the paragraph

below the only system list table in Aqua's anticipated Southwest Region sewer utility tariff.⁴ Upon approval of this application, those references to "Rebecca Creek (Comal County)" should be removed from both tariffs. Second, the water CCN area Aqua is to receive will include a subdivision the developer has decided to call "Villas at Cranes Mill Marina." Aqua plans to use its Canyon Lake Mobile Home Estates water system (PWS ID No. 0460063) to serve that area and apply Aqua's water service rates applicable to that system. Thus, with the approval of this application, Aqua's Southwest Region water utility tariff should reflect the addition of "Villas at Cranes Mill Marina" to the list of subdivisions/areas served by the Canyon Lake Mobile Home Estates water system in Table C.⁵


