ORDER NO. 10 FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the notice of the application filed on December 1, 2020 by Nevada Special Utility District to amend its water certificate of convenience and necessity number 12175 and to decertify portions of certificated water service areas of Caddo Basin Special Utility District, Copeville Special Utility District, and the City of Josephine in Collin County. On December 30, 2020, Commission Staff filed a recommendation on the sufficiency of notice.

On December 1, 2020, Nevada SUD filed an affidavit of notice attesting that notice of the application was mailed to the landowners and entities identified in the affidavit on November 16, 2020. Also included was Nevada SUD's publisher's affidavit showing that notice was published in a newspaper of general circulation on November 19, and 26, 2020.

The administrative law judge finds notice sufficient and establishes the following procedural schedule for continued processing:

Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to Nevada SUD, Caddo Basin SUD, Copeville SUD, and the City of Josephine for review and consent	February 24, 2021
Deadline for Nevada SUD, Caddo Basin SUD, Copeville SUD, and the City of Josephine to file signed consent forms with the Commission	March 10, 2021

If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	March 17, 2021
If no hearing is requested, deadline for the parties to file joint proposed findings of fact and conclusions of law	March 24, 2021
