**COMMISSION STAFF'S REQUEST FOR EXTENSION AND REVISED
PROCEDURAL SCHEDULE**

On December 30, 2019, Nevada Special Utility District (Nevada SUD) filed an application to amend its water Certificate of Convenience and Necessity (CCN) 12175 through the addition of service area, and to decertify those portions of certificated water service areas of Caddo Basin Special Utility District (Caddo Basin SUD), Copeville Special Utility District (Copeville SUD), and the City of Josephine in Collin County that will be added to Nevada SUD's existing service area. The requested service area consists of 1,377.8 acres and 14 customer connections.

On February 25, 2020, the administrative law judge (ALJ) issued Order No. 11 requiring the Staff of the Public Utility Commission of Texas (Staff) to provide final maps, certificates, and tariffs to Nevada SUD, Caddo Basin SUD, Copeville SUD, and the City of Josephine by March 10, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION AND REVISED PROCEDURAL SCHEDULE

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Nevada SUD opened Docket No. 49548¹ to finalize the conversion process from a Water Supply Corporation to a Special Utility District but that conversion process was never finalized in that docket. To complete this docket and officially establish Nevada SUD as a Special Utility District, Staff requested that Nevada SUD file the necessary documentation for the name change and they did so on March 2, 2021. To proceed with

this docket, Staff requires additional time to review that documentation and make a recommendation on the name change. Therefore, Staff proposes the following revised procedural schedule for further processing of this docket:

| Deadline for Staff to make a recommendation on the name change from a Water Supply Corporation to a Special Utility District | March 24, 2021 |
| Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to Nevada SUD, Caddo Basin SUD, Copeville SUD, and the City of Josephine for review and consent | April 21, 2021 |
| Deadline for Nevada SUD, Caddo Basin SUD, Copeville SUD, and the City of Josephine to file signed consent forms with the Commission | May 5, 2021 |
| If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application | May 12, 2021 |
| If no hearing is requested, deadline for the parties to file joint proposed findings of fact and conclusions of law | May 26, 2021 |

II. CONCLUSION

For the reasons stated above, Staff respectfully requests that an order be issued consistent with the foregoing request.
