# PETITIONER'S MOTION FOR ENTRY OF ORDER GRANTING ADMINISTRATIVE APPROVAL

### TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

Sterling Deason O'Donnell and Darwin Deason, co-trustees of the Sterling Deason O'Donnell DD 2012 Trust under agreement of the DD 2014-B Grantor Retained Annuity Trust (the "Petitioner") files its Motion for Entry of Order Granting Administrative Approval of its Petition for Expedited Release (the "Petition") and shows as follows:

The Petition was filed on January 2, 2020. The Administrative Law Judge ("ALJ") issued an order finding the Petition Administratively Complete on June 12, 2020. *See* Order No. 5. On June 26, 2020, Staff timely filed its Recommendation on Final Disposition of this matter, which recommended the Petition's approval.

On July 1, 2020 Petitioner timely filed its Reply to Marliee Special Utility District's Response to the Petition and Commission Staff's Recommendation on Final Disposition.

According to the Procedural Schedule established in Order No. 5, the deadline for administrative approval of the Petition was August 11, 2020. Petitioner has not yet received an Order regarding final disposition of this matter.



WHEREFORE, Petitioner respectfully requests that this Court enter an Order approving Commissions Staff's final recommendation and GRANTING, or, alternatively an Order clarifying that the Petition was approved by operation of Law on August 11, 2020.
