**MARILEE SPECIAL UTILITY DISTRICT'S MOTION TO INTERVENE**

COMES NOW, MARILEE SPECIAL UTILITY DISTRICT ("Marilee SUD") and files this Motion to Intervene pursuant to 16 Texas Administrative Code (TAC) §§ 22.101, et. seq. In support thereof, Marilee SUD respectfully would show as follows:

1. On January 2, 2020, Sterling Deason O'Donnell and Darwin Deason, Co-Trustees of the Sterling Deason O'Donnell DD 2012 Trust under agreement of the DD 2014-B Grantor Retained Annuity Trust Dated September 5, 2012 ("Petitioner") filed a petition for streamlined expedited release from Marilee SUD's Certificate of Convenience and Necessity (CCN) No. 10150, where the property subject to the Petition is approximately 260.372 contiguous acres in Collin County (the "Property").

2. Thus, in accordance with 16 TAC § 22.104(b), Marilee SUD timely files this Motion to Intervene.

3. Marilee SUD has an interest in maintaining its CCN areas and protecting its investments in its infrastructure, and therefore Marilee SUD requests party status to allow it to continue to argue and respond to substantive issues raised in this proceeding,




