# THE SANCTUARY TEXAS, LLC'S MOTION TO ENLARGE TIME TO FILE AFFIDAVIT

#### TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

The Sanctuary Texas, LLC ("Petitioner") files this Motion to Enlarge Time to File Affidavit and in support thereof respectfully shows as follows:

- 1. On April 15, 2020, Order No. 4 was issued requesting Petitioner to provide an affidavit signed by Daniel W. Brooks, trustee of the property, attesting that he concurs with the petition for expedited release by today's date.
- 2. Petitioner did not receive notice of Order No. 4 until April 22, 2020 when it was mentioned in a supplemental response to amended petition, filed in a companion case in Docket No. 50495.
- 3. Petitioner has employed its best efforts, but it has been unable to obtain a signed affidavit within the past 4-5 business days. Mr. Brooks is not personally known to Petitioner's representative. He is simply an employee of the lender who signed the deed of trust to secure the lien on the property that is the subject of this docket. Petitioner continues to diligently work with the lender to obtain Mr. Brooks's affidavit.
- Petitioner, therefore, respectfully requests an additional two weeks to obtain and 4. file the Affidavit of Mr. Brooks.
