



APPLICATION OF MONARCH UTILITIES 1, L.P. AND GOINS UTILITY SERVICE LLC FOR SALE, TRANSFER, OR MERGER OF FACILITIES AND UNCERTIFICATED AREA OF POLK COUNTY

COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS, PROPOSED NOTICE, AND PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and in response to Order No. 4, files this Supplemental Recommendation on Administrative Completeness, Proposed Notice, and Procedural Schedule. Staff recommends that the application be deemed administratively complete. In support thereof, Staff shows the following:

I. BACKGROUND

On January 8, 2020, Monarch Utilities 1, L.P. (Monarch) and Goins Utility Service LLC (Goins) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and uncertificated area in Polk County. Monarch seeks to purchase all the water and wastewater assets of Goins. The requested sale and transfer includes 36 connections and approximately 17 total acres for the requested water service area and approximately 24 total acres for the requested sewer service area. The Applicants filed supplemental information to their application on March 10, 2020, April 7, 2020, and on April 27, 2020.

On April 20, 2020, the Commission administrative law judge (ALJ) issued Order No. 4, requiring Staff to file a supplemental recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule for further processing of the application, by June 8, 2020. Therefore, this pleading is timely filed.

II. ADMINISTRATIVE COMPLETENESS

Staff has reviewed the application and supplemental information filed by the Applicants and, as detailed in the attached memorandum from Heidi Graham, Infrastructure Division, recommends that it be found administratively complete and accepted for filing. Staff's recommendation on administrative completeness is not a comment on the merits of the application, but only that the application content is complete for further processing.

III. NOTICE

As detailed in the attached memorandum, Staff recommends that the Applicants proceed with providing notice. Staff notes that Monarch has requested that the water and sewer rates be increased to Monarch's existing rates, phased in over a five-year period as a result of the transaction. The merits of the requested rate change will be addressed in Staff's final recommendation, and Staff has amended the notice forms attached to provide notice to Goins' customers of Monarch's requested rate.

Staff recommends that the Applicants be directed to use the attached *Notice for Publication* form to publish notice once each week for two consecutive weeks in a newspaper of general circulation in Polk County. Staff further recommends that the Applicants be directed to use the attached *Notice to Neighboring Systems, Landowners, Customers and Cities* form to complete the following actions:

- 1) Provide notice of the application to the following:
 - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
 - David Lee Sheffield (CCN No. 11997)
 - Lake Livingston Water Supply & Sewer Service (CCN No. 10147)
 - Texas Landing Utilities (CCN No. 20569)
 - Trinity River Authority of Texas
 - b. The county judge of each county that is wholly or partially included in the requested area;
 - Polk County Judge
 - c. Each groundwater conservation district that is wholly or partially included in the requested area;
 - Lower Trinity GCD
 - d. Landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the requested area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the requested area is located;

- e. Any affected customers, and other affected parties in the requested area; and
- f. Publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Polk County.
- 2) Provide an accurate map delineating the requested service area with each individual notice to neighboring utilities, other affected parties, landowners and customers. Information related to districts including addresses can be obtained by the Applicant from the TCEQ web site located at http://www14.tceq.texas.gov/iwud/.
- 3) File in the docket a map and copy of notice along with an affidavit specifying every person and entity to whom notice was provided and the date that the notice was provided. It is recommended that the Applicant use the attached notice and affidavit to meet these requirements.

IV. PROCEDURAL SCHEDULE

Staff recommends the application be found administratively complete. Therefore, Staff proposes the following procedural schedule:

V. CONCLUSION

On January 8, 2020, Monarch Utilities 1, L.P. (Monarch or Purchaser) and Goins Utility Service LLC (Goins or Seller) (collectively, Applicants) filed an application for Sale, Transfer, or Merger (STM) of facilities and certificate rights in Polk County, Texas, according to Texas Water Code (TWC) §§ 13.242 to 13.250 and § 13.301 and 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237 and § 24.239.

Specifically, Monarch, water Certificate of Convenience and Necessity (CCN) No. 12983 and sewer CCN No. 20899, seeks approval to acquire facilities and to incorporate all of Goins' water and sewer uncertificated service area. In addition, Lake Livingston Water Supply & Sewer Service, CCN No. 10147, has agreed to decertify a portion of its water service area, which is approximately 5 acres, and Monarch requests to amend the area to CCN No. 12983.

The requested water service area includes approximately $\underline{17}$ total acres and $\underline{36}$ current customers.

The requested sewer area includes approximately 24 total acres and 36 current customers.

The area of Lake Livingston Water Supply & Sewer Service (CCN No. 10147) to be decertified is approximately <u>5</u> acres and has no customers.

The Staff from the Infrastructure Division and the Rate Regulation Division have reviewed the application and supplemental information filed by the Applicants and recommend that the application be deemed sufficient for filing and found administratively complete. Staff further recommends the Applicants be ordered to do the following:
