"My name is George Freitag, and I am the Texas Regulatory Manager for SouthWest Water Company, parent of Monarch Utilities I L.P. I am capable of making this affidavit. I am over 21 years of age, have personal knowledge of the facts herein set out, and am fully qualified to make this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct."

- On January 8, 2020, Monarch Utilities 1, L.P. (Monarch) and Goins Utility Service LLC (Goins) (collectively, Applicants) filed an application with the Public Utility Commission of Texas for approval of the sale, transfer, or merger of facilities and uncertificated area in Polk County. The requested sale and transfer includes 36 connections and approximately 17 total acres for the requested water service area and approximately 24 total acres for the requested sewer service area.
- 2. On July 28, 2020 all current customers and other affected entities were mailed the notice of transfer.
- 3. There are no tracts of land that are at least 25 acres wholly or partly located in the requested areas to be certified and no such landowners exist.
