**FOURTH MOTION TO AMEND PROCEDURAL SCHEDULE**

Monarch Utilities I L.P. (Monarch) files this Fourth Motion to Amend Procedural Schedule in this docket. The Staff of the Public Utility Commission of Texas (Commission Staff) is unopposed to this motion. In support, Monarch would respectfully show the following:

**I. BACKGROUND**

In Order No. 12, issued January 21, 2021, the Administrative Law Judge (ALJ) adopted an amended procedural schedule that included a deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed, by March 22, 2021.<sup>1</sup> Monarch and Commission Staff are in the process of settlement negotiations and would request additional time to continue settlement discussions.

**II. MOTION TO REQUEST EXTENSION OF PROCEDURAL SCHEDULE**

Monarch requests that the ALJ adopt the following Amended Procedural Schedule:

<b>Event</b>	<b>Date</b>
Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing transaction to proceed.	April 5, 2021
120-day deadline for Commission to approve the sale or require a hearing	April 12, 2021

Counsel for Monarch has conferred with counsel for Commission Staff regarding this Amended Procedural Schedule, and represents that Commission Staff is unopposed to the filing.
