MONARCH UTILITIES I L.P.'S REQUEST FOR EXTENSION

Monarch Utilities I L.P. (Monarch) files this Request for Extension and would respectfully show the following:

I. BACKGROUND

On July 1, 2021, the Public Utility Commission of Texas (Commission) administrative law judge issued Order No. 18, establishing August 24, 2021 as the date by which the parties would jointly file a proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs (collectively, a "Proposed Order").

II. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code § 22.4(b), Monarch requests to extend the deadline to jointly file a Proposed Order for 14 days, to September 7, 2021. Monarch has been in contact with Commission Staff about an issue with the wastewater tariff filed with the consent forms on August 17, 2021. Monarch and Commission Staff believe additional time is needed to resolve the issue before filing the joint Proposed Order. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. Monarch has conferred with Kevin Bartz, counsel for Commission Staff, who has stated he has no objection to this request.

III. CONCLUSION

Monarch respectfully requests the issuance of an order granting Monarch's request and extending the deadline to jointly file a proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs to September 7, 2021.
