Monarch Utilities I L.P. (Monarch) and Staff of the Public Utility Commission of Texas files (Commission Staff) (collectively, Movants) file this Joint Motion to Amend Procedural Schedule in this docket. In support, Movants would respectfully show the following:

**I. BACKGROUND**

In Order No. 19, issued August 24, 2020, the Administrative Law Judge (ALJ) granted Monarch’s request for extension to file the joint proposed order, by September 7, 2021. Monarch and Commission Staff have identified issues in the wastewater tariff, and would request additional time to resolve these issues and file amended consent forms.

**II. MOTION TO REQUEST EXTENSION OF PROCEDURAL SCHEDULE**

Movants request that the ALJ adopt the following Amended Procedural Schedule:
