**JOINT REQUEST FOR EXTENSION**

On January 8, 2020, Monarch Utilities I L.P. (Monarch) and Goins Utility Service LLC (Goins) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and uncertificated area in Polk County. Monarch seeks to purchase all the water and wastewater assets of Goins. The requested sale and transfer includes 36 connections and approximately 17 total acres for the requested water service area and approximately 24 total acres for the requested sewer service area. The Applicants filed supplemental information to their application on March 10, 2020, April 7, 2020, and on April 27, 2020.

On August 24, 2021, the administrative law judge (ALJ) filed Order No. 20 setting a deadline of September 10, 2021 for the applicants to file the consent forms in this matter, and a deadline of September 17, 2021 for the parties to file the joint motion to admit evidence and proposed order and findings of fact.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. The parties require additional time to finalize a clarification regarding the final tariffs in this matter. Therefore, the parties respectfully request that the deadline to file the consent forms and related items be extended until September 17, 2021 and that the deadline to file the joint motion to admit evidence and proposed order and findings of fact be extended until September 24, 2021.

## II. CONCLUSION

Staff respectfully requests that the deadlines be extended as requested above.
