

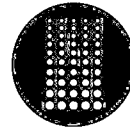

To the Commission:

Ordering Paragraph III. 8 in the Notice of Approval issued in this Docket requires both Monarch and Lake Livingston to comply with the recording requirements in TWC § 13.257(r) and (s) for the areas in Polk County affected by this application and file in this docket proof of evidence of the recording no later than 45 days after receipt of this Notice of Approval.

Both Monarch and Lake Livingston filed the required documents with Polk County late in December well before the deadline. However, the county still has not returned the official recording evidence to Monarch. Attached is the proof of evidence of recording by Lake Livingston Water Supply Corporation.

Monarch respectfully requests an extension of time of 30 days to file its proof of compliance with the order.

"My name is Kim Click, and I am the General Manager for Lake Livingston Water Supply and Sewer Service Corporation (LLWSSC). I am capable of making this affidavit. I am over 21 years of age, have personal knowledge of the facts herein set out, and am fully qualified to make this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct."

1. LLWSSC's primary business is providing retail water and wastewater utility services and is the service provider of water and wastewater for various service areas in the State of Texas including but not limited to Polk County, Texas.
2. LLWSSC is the holder of water Certificate of Convenience and Necessity Number 10147.
3. On December 3, 2021, Monarch Utilities I.L.P.'s acquisition of the water and wastewater service areas of Goins Utility Service LLC was approved by final Order of the Public Utility Commission of Texas in Docket Number 50424. In that filing approximately 6 acres of LLWSSC's water service area was decertified and transferred to Monarch.
4. This filing updates and supersedes any previous filings by Monarch, Goins Utility Service LLC, or LLWSC of certified maps showing the water service areas in Polk County.
5. This affidavit contains as an attachment the certified maps showing the utility service area and boundary description he transferred areas in Polk County, Texas.
6. This affidavit is being filed and recorded in the Real Property Records of Polk County, Texas, pursuant to Section 13.257 (r) and (s) of the Texas Water Code.

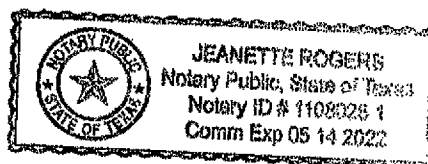

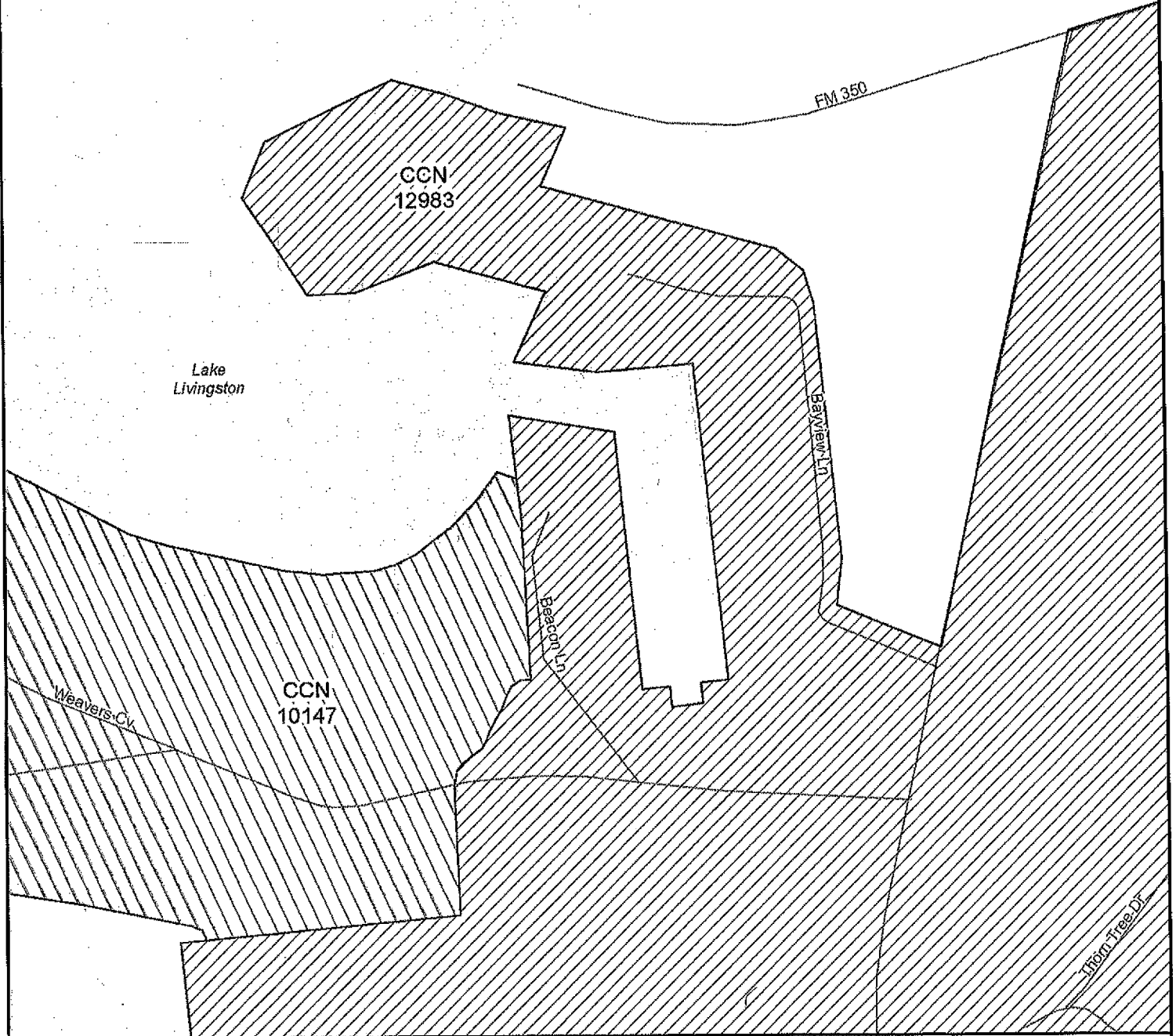

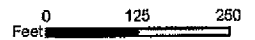
