This Application seeks Commission approval, to the extent required, to relinquish and terminate SICFA No. 90037 held by NTS Telephone Company, LLC ("NTS-Tel") effective January 1, 2020.

Effective December 31, 2019, NTS-Tel merged with and into NTS Communications, LLC ("NTS-Comm," together with NTS-Tel, the "Parties"), an affiliate of NTS-Tel, with NTS-Comm surviving the merger (the "Pro Forma Consolidation"). As a result of the Pro Forma Consolidation, NTS-Tel ceased to exist as a separate entity and no longer requires its SICFA. NTS-Comm has filed an application for amendment to its SICFA to incorporate NTS-Tel's Service Area Footprint into NTS-Comm's SICFA No. 90011. See Tracking No. J7MYPZDX.

Since NTS-Tel does not exist or provide cable and video services in Texas under its SICFA, the relinquishment and termination of NTS-Tel's SICFA is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity. Diagrams depicting the *Pro Forma* Consolidation and the current ownership structure of the Parties are provided as <u>Exhibit A</u>.

NTS-Tel merged with and into NTS Communications, LLC effective December 31, 2019 and NTS-Tel ceased to exist as a separate entity. Therefore, this Application seeks Commission approval, to the extent required, to relinquish and terminate NTS-Tel's SIFCA effective January 1, 2020.

4. As stated in PURA Sec. §66.004(a), an applicant is not eligible to seek a SICFA until the expiration date of an existing municipal franchise agreement for a requested Service Area Footprint. To meet this eligibility requirement, Commission Staff has determined that an Applicant may file an application for a SICFA within 17 business days of the expiration date of its existing municipal franchise agreement. To determine eligibility, the Commission Staff requires the following information:

a. Is the Service Area Footprint requested in this application currently or previously under a municipal franchise agreement entered into by this applicant or an affiliate of this applicant? If yes, answer question (b).

b. What is or was the expiration date of the municipal franchise agreement for the requested Service Area Footprint?

This Application provides the Commission with written notification to terminate SICFA No. 90037 of NTS-Tel. Written notification to the Commission of termination of NTS-Tel's SICFA by a court or the FCC, and copies of orders or


rulings issued by the courts or the FCC concerning NTS-Tel's SICFA, will be provided in the event such occurs.
