COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Supplemental Recommendation on Administrative Completeness and Proposed Procedural Schedule in response to Order No. 2. Staff recommends that the application be deemed administratively complete. In support thereof, Staff shows the following:

I. BACKGROUND

On January 23, 2020, Crystal Clear Special Utility District (Crystal Clear SUD) and the City of San Marcos (San Marcos) (collectively, "Applicants") filed an application for sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Hays County. Crystal Clear SUD seeks to transfer its water service area held under CCN No. 10297 to San Marcos. The requested sale and transfer includes approximately 475 acres and 489 connections. Applicants filed supplemental information on March 20, 2020.

On February 26, 2020, Order No. 2 was issued establishing a deadline of April 24, 2020, for Staff to file a supplemental recommendation on the administrative completeness of the application and to propose a procedural schedule for further processing of the application. Therefore, this pleading is timely filed.

II. ADMINISTRATIVE COMPLETENESS

Staff has reviewed the application and supplemental information filed by Applicants and, as detailed in the attached memorandum from Elisabeth English, Infrastructure Division, recommends that it be found administratively complete and accepted for filing. Staff's recommendation does not address the merits of the petition.

III. NOTICE

As detailed in the attached memorandum, Staff recommends that Applicants proceed with providing public notice. Specifically, Staff recommends that Applicants be directed to use the attached *Notice to Current Customers*, *Neighboring Systems*, *and Cities* form to complete the following actions:

- 1) Provide notice of the application by first-class mail to the following:
 - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:
 - Crystal Clear SUD (CCN No. 10297)
 - b. The county judge of each county that is wholly or partially included in the requested area:
 - Hays County Judge
 - c. Each groundwater conservation district that is wholly or partially included in the requested area:
 - Barton Springs-Edwards Aquifer Conservation District
 - Canyon Regional Water Authority
 - Edwards Aquifer Authority
 - Guadalupe-Blanco River Authority
 - Upper San Marcos Watershed Reclamation & Flood Control District
 - d. Any affected customers, and other affected parties in the requested area.

Addresses can be obtained by the Applicant from the Water Utility Database at http://www.puc.texas.gov/watersearch. Information related to districts including addresses can be obtained from the Texas Commission on Environmental Quality's (TCEQ) web site located at http://www14.tceq.texas.gov/iwud/.

- 2) Provide notice and proof of notice using the attached notice and affidavit forms.
- 3) Provide a copy of the map delineating the requested area with each individual notice to neighboring utilities, other affected parties, and customers.
- 4) File in the docket an affidavit specifying every person and entity to whom notice was provided and the date that the notice was provided. Also file a representative copy of the actual notice and a copy of the map that was included with each individual notice.

IV. PROCEDURAL SCHEDULE

Staff recommends the application, as supplemented, be found administratively complete. Staff therefore proposes the following procedural schedule:

Deadline for Applicant to file with the Commission signed affidavits that the notice was given along with a copy of the notice sent to the affected parties and published in a newspaper of general circulation	May 25, 2020
Deadline for Staff to file a recommendation on sufficiency of notice	June 1, 2020
Deadline to intervene	Thirty (30) days after notice is issued

V. CONCLUSION

For the reasons detailed above, Staff recommends that the application, as supplemented, be found administratively complete, that Applicants be directed to provide notice as detailed above and in the attached memorandum, and that the proposed procedural schedule be adopted.

On January 23, 2020, Crystal Clear Special Utility District (Crystal Clear SUD) and City of San Marcos (San Marcos) (collectively "Applicants") filed an application for Sale, Transfer, or Merger (STM) of certificate rights and facilities in Hays County, Texas. The STM application is being reviewed consistent with 16 Texas Administrative Code (TAC) §§ 24.227 and 24.239 and Texas Water Code (TWC) §§ 13.241, 13.246, and 13.301. San Marcos seeks approval for the purchase of Crystal Clear SUD's facilities, an amendment to their water Certificate of Convenience and Necessity (CCN) No 10298, and for the decertification of the transferred portion of Crystal Clear SUD's water CCN No. 10297.

On March 20, 2020 the Applicants supplemented their application with sufficient information to address Staff's previously noted deficiencies. Staff recommends that the application be deemed administratively complete. Staff further recommends the Applicants be ordered to do the following:

- 1) Provide notice of the application by first-class mail to the following:
 - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:
 - Crystal Clear SUD (CCN No. 10297)
 - b. The county judge of each county that is wholly or partially included in the requested area:
 - Hays County Judge
 - c. Each groundwater conservation district that is wholly or partially included in the requested area:
 - Barton Springs-Edwards Aquifer Conservation District
 - Canyon Regional Water Authority
 - Edwards Aquifer Authority
 - Guadalupe-Blanco River Authority
 - Upper San Marcos Watershed Reclamation & Flood Control District
 - d. Any affected customers, and other affected parties in the requested area.

Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed, Staff may send requests for information (RFI) to the Applicant. The Applicant will have 20 days from the receipt of the RFI.

The requested area to be transferred is located approximately 2 miles southwest of downtown San Marcos, TX, and is generally bounded on the north by Los Santos Drive and Purgatory Creek Natural Area; on the east by Hunter Road; on the south by intersection of West McCarty Lane and Hunter Road; and on the west by West McCarty Lane. The requested area to be transferred includes approximately 475 total acres and 489 current customers. See enclosed map showing the requested area or https://www.sanmarcostx.gov/205/Water-Wastewater.

This transaction will have the following effect on the current customers' rates and services: This transaction will result in the City of San Marcos charging customers of the Willow Creek Subdivision their water rates. The majority of customers will see lower monthly water bills.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
