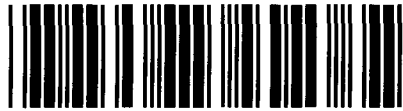

COMMISSION STAFF'S REQUEST FOR AN EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Commission Staff's Request for an Extension.

I. BACKGROUND

On January 30, 2020, Kenneth V Land and Greg Coburn (collectively, Applicants) applied for what appears to be a transfer of an exempt utility and associated registration number N0063. Specifically, Kenneth V Land is transferring his exempt utility and associated registration to the current landowner, Greg Coburn. The application includes a current warranty deed filed with Comal County and states that no compensation has been exchanged.

Order No. 1, issued February 3, 2020, set February 26, 2020 as the deadline for Staff to file comments regarding this application, recommendations regarding notice, under what applicable law this proceeding was filed and would be processed, and propose a procedural schedule, if appropriate. Therefore, this pleading is timely filed.

II. REQUEST FOR AN EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff is continuing to review the Applicants' application, discuss how this docket might best be processed, and to prepare a responsive pleading to Order No. 1. Staff would therefore respectfully request a 30-day extension to allow sufficient time for Staff to review and finalize its recommendation.

III. CONCLUSION

Staff respectfully requests the entry of an order setting March 27, 2020 as Staff's deadline to file its recommendation.
