COMMISSION STAFF'S JOINT PROPOSED PROCEDURAL SCHEDULE

On February 12, 2020, SP Utility Company, Inc. (SP Utility) filed an application to amend its water certificate of convenience and necessity (CCN) number 12978 and for dual certification with Drew T. Spencer dba Cypresswood Estates Water System in Montgomery County, Texas. The requested area consists of 256 acres and 151 customer connections. SP Utility filed supplemental information on April 10, 2020, April 13, 2020, April 16, 2020, September 9, 2020, November 2, 2020, November 6, 2020, and December 7, 2020.

On March 1, 2021, the administrative law judge (ALJ) filed Order No. 13, establishing a deadline of March 8, 2021 for Staff of the Public Utility Commission of Texas (Staff) and SP Utility (collectively, Parties) to file a joint proposed procedural schedule for further processing of this docket. Therefore, this pleading is timely filed.

I. JOINT PROPOSED PROCEDURAL SCHEDULE

Staff has conferred with counsel for SP Utility and the Parties jointly propose the procedural schedule below for further processing of this docket.

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to SP Utility for review and consent	May 6, 2021
Deadline for SP Utility to file signed consent forms with the Commission	May 20, 2021
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	May 27, 2021
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	June 3, 2021

II. CONCLUSION

Staff respectfully requests that the joint proposed procedural schedule be adopted.
