#### **DEFINITIONS**

- Staff 3-1 Please provide the approval letter from the Texas Commission on Environmental Quality for the new distribution system to be installed by SP Utility to serve the customers in the area.
- Staff 3-2 Admit or deny the new distribution system to be installed by SP Utility will replace the entire existing distribution system of Cypresswood Estates.
- Staff 3-3 Admit or deny that once the new distribution system is installed, the customers being served by the new system will be charged the rates contained in SP Utility's current, approved tariff.
- Staff 3-4 Admit or deny that SP Utility will submit an application to the Commission on behalf of Cypresswood Estates in order to cancel the certificate of convenience and necessity held by Cypresswood Estates, once all customers currently being served are fully served only by SP Utility.
