Staff 4-1: Please provide the approval letter from the Texas Commission on Environmental Quality for the new distribution system to be installed by SP Utility to serve the customers in the area. A TCEQ approval letter was submitted in response to Staff RFI 3-1, but that approval letter was for the proposed water plant.

RESPONSE: SP Utility reasserts its position that title 16 Tex. Admin. Code § 24.233(a)(14)(A) does not require the submittal of plan approval by TCEQ as a precondition to the issuance of the requested CCN amendment by the Commission in this case. Notwithstanding that, please see attached Exhibit A, TCEQ's June 30, 2021 plan approval.

On June 7, 2021, the Texas Commission on Environmental Quality (TCEQ) received planning material with your letter dated June 4, 2021 for the proposed distribution system modifications. Additional information was received on June 24, 2021 via email. Based on our review of the information submitted, the project generally meets the minimum requirements of Title 30 Texas Administrative Code (TAC) Chapter 290 – Rules and Regulations for Public Water Systems and is approved for construction.

The submittal consisted of 4 sheets of engineering drawings and technical specifications. The approved project consists of:

- 2,487 linear feet (LF) of 6-inch, AWWA Standard C900, dimension ratio (DR) 18, polyvinyl chloride (PVC) waterline;
- 16,140 LF of 3-inch, American Society for Testing and Materials (ASTM) Standard D2241, SDR 21, Class 200 PVC waterline;
- 3,000 LF of 1-inch ASTM D3035 SDR 9, minimum pressure rating 200 psi service lines with
 %-inch meters to serve existing 145 residence; and
- Various valves, fittings, and appurtenances.

This approval is for the construction of the above listed items only.

The authorization provided in this letter does not relieve a Public Water System from the need to comply with other applicable state and federal regulations.

We note that an application has been filed with Public Utility Commission (Control Number 50543) for SP Utility Company Inc.'s Water Certificate of Convenience and Necessity (CCN No. 12978) service area amendment.

The Cypresswood Subdivision Water System public water supply system provides water treatment.

The project is located along Sanders Road, Spencer Boulevard, Zahn Street, Oak Run, Rolling Timbers Street and Sanders Cemetery Road, in Montgomery County, Texas.
