

APPLICATION OF KELLY G. § PUBLIC UTILITY COMMISSION BREWER FOR A CLASS D ANNUAL § RATE ADJUSTMENT § OF TEXAS

## COMMISSION STAFF'S REQUEST FOR EXTENSION

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for Extension. In support, Staff shows the following:

#### I. BACKGROUND

On February 14, 2020, Kelly G. Brewer (Mr. Brewer) filed an application for an annual rate adjustment under Texas Water Code (TWC) § 13.1872. A motion to dismiss the application for failure to prosecute was considered at the Open Meeting held on November 19, 2020. During the open meeting, it was recommended that Staff again attempt to contact Mr. Brewer, and, following that effort, submit a filing.

Staff submitted a status report on December 9, 2020, and on December 10, 2020 the administrative law judge filed Order No. 5, which established a deadline of January 28, 2021 for Staff to make a supplemental recommendation on the administrative completeness of the application. Therefore, this pleading is timely filed.

## II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff continues to review the supplemental materials provided by Mr. Brewer. Therefore, Staff requests an extension of the deadline to file its supplemental recommendation on the administrative completeness of the application.
