**COMMISSION STAFF'S RECOMMENDATION ON AMENDED MAPS AND  
PROPOSED AMENDED PROCEDURAL SCHEDULE**

On February 18, 2020, the City of Alton (Alton) filed an application to amend its sewer certificate of convenience and necessity (CCN) No. 20809 in Hidalgo County. The requested area consists of 1,434 total acres and 76 customer connections.

On May 11, 2021, the administrative law judge filed Order No. 11, amending the procedural schedule and requiring Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the amended maps by July 9, 2021. Therefore, this pleading is timely filed.

**I. RECOMMENDATION ON AMENDED MAPS**

As of July 8, 2021, Alton has not filed amended maps in this proceeding as required by Order No. 11. Therefore, Staff cannot make a recommendation on amended maps.

**II. PROPOSED AMENDED PROCEDURAL SCHEDULE**

In accordance with its recommendation, Staff proposes to amend the procedural schedule as follows:

Deadline for Alton to file amended maps	August 5, 2021
Deadline for Staff to file a recommendation on the amended maps	September 3, 2021
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to applicant for review and consent	October 8, 2021
Deadline for Alton to file signed consent forms with the Commission	October 22, 2021
If no hearing is requested, deadline for Commission	November 5, 2021

Staff to file a final recommendation on the application	
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	November 19, 2021

#### IV. CONCLUSION

For the reasons detailed above, Staff respectfully request that the amended procedural schedule be adopted.
