
**MSEC WASTE WATER, INC.'S



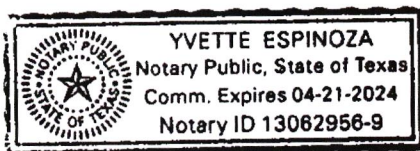

The proposed rates will apply to service received after the effective date provided below, unless modified or suspended by the Commission. If the Commission receives a sufficient number of protests, separately or in a combined protest letter, from at least [one] ratepayer (10 percent of the utility's customers over whose rates the Commission has original jurisdiction) or from any affected municipality before the 91st day after the proposed effective date, the matter will be set for hearing. It seeks to align MSEC Wastewater's rate design with the current level of expanded operations and enable the utility to recover its operations and maintenance expenses and a reasonable return on investment.
