COMMISSION STAFF'S REQUEST FOR EXTENSION

On March 9, 2020, MSEC Waste Water, Inc. (MSEC) filed as a Class D Utility using a Class C rate change application for its sewer customers. MSEC holds sewer certificate of convenience and necessity (CCN) No. 20984 with a total of 10 active connections

On June 2, 2021, the administrative law judge (ALJ) filed Order No. 13, requiring the Staff of the Public Utility Commission of Texas (Staff) to request a hearing or file a recommendation on final disposition on or before June 18, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to finalize its final recommendation. Therefore, Staff respectfully requests that the deadline for Staff to file its final recommendation be extended to June 30, 2021.¹

II. CONCLUSION

Staff respectfully requests the issuance of an order granting Staff's request and extending the deadline for Staff to file its final recommendation to June 30, 2021.

¹ Staff acknowledges that the June 25, 2021 is the 120th day after MSEC's proposed effective date of February 25, 202, which is the last day the Commission may set this matter for a hearing under 16 TAC § 24.35(c)(1). Staff does not plan to request a hearing on the application at this time. Therefore, Staff believes that it is permissible to request an extension of its deadline to file a final recommendation beyond June 25, 2021.
