COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for Extension. In support thereof, Staff shows the following:

I. BACKGROUND

On March 9, 2020, MSEC Waste Water, Inc. (MSEC or the Applicant) filed an application for a Class D annual rate adjustment for its sewer customers. MSEC holds sewer certificate of convenience and necessity (CCN) number 20984 with a total of 3 active connections.

On March 12, 2020, the administrative law judge (ALJ) issued Order No. 1, directing MSEC to file additional information and supporting documentation by March 23, 2020, and directing Staff to file comments on the administrative completeness of the application and notice, and, if necessary, to file a recommendation on final disposition including the proposed tariff sheet reflecting the requested rate change by April 8, 2020. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review the application and make a determination regarding the administrative completeness of the application and notice. As such, Staff requests that the deadline for Staff to file its comments on the administrative completeness of the application and notice be extended to April 15, 2020.

III. CONCLUSION

Staff respectfully requests the issuance of an order granting Staff's request and extending the deadline for Staff to file comments on the administrative completeness of the application and notice to April 15, 2020.
