COMMISSION STAFF'S REQUEST FOR EXTENSION

On February 24, 2020, Polonia Water Supply Corporation (Polonia WSC) and the City of Lockhart (Lockhart) (collectively, the Applicants) filed an application for sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Caldwell County. Polonia WSC seeks to transfer a portion of its water service area held under CCN number 10420 to Lockhart. The requested area includes approximately 2,373 acres and 25 connections.

On March 17, 2021, the administrative law judge (ALJ) filed Order No. 12 requiring the Staff of the Public Utility Commission of Texas (Staff) to provide final maps, certificates, and tariffs (if applicable), to applicants for review and consent by March 24, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to prepare and provide the final map and certificate to the Applicants. Thus, Staff requests the following revised procedural schedule be adopted:

Events	Date
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to the Applicants for review and consent	March 31, 2021
Deadline for the Applicants to file signed consent forms with the Commission	April 14, 2021
Deadline for parties to jointly file Proposed Notice of Approval, including findings of fact, conclusions of law, and ordering paragraphs	April 21, 2021

II. CONCLUSION

Staff respectfully requests the issuance of an order consistent with the above request for extension.
