COMMISSION STAFF'S CLARIFICATION

On February 24, 2020, Polonia Water Supply Corporation (Polonia WSC) and the City of Lockhart (Lockhart) (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Caldwell County. Polonia WSC seeks to transfer a portion of its water service area held under CCN number 10420 to Lockhart. The requested area includes approximately 2,373 acres and 25 connections.

On May 7, 2021, the administrative law judge filed Order No. 14 requiring the Staff of the Public Utility Commission of Texas (Staff) to clarify whether it consulted with Pam Balser and Alan Wayne Balser (collectively, Intervenors) regarding their position on the joint supplemental motion to admit evidence and proposed notice of approval by May 14, 2021. Therefore, this pleading is timely filed.

I. CLARIFICATION ON PROPOSED NOTICE OF APPROVAL

Staff inadvertently did not consult the Intervenors before filing the April 21, 2021 joint supplemental motion to admit evidence and proposed notice of approval. Staff has since contacted the Intervenors on May 11, 2021, and the Intervenors expressed that they were unopposed to the April 21, 2021 joint supplemental motion to admit evidence and proposed notice of approval.

II. CONCLUSION

Staff respectfully provides this clarification in response to Order No. 14.
