**ORDER NO. 2**  
**GRANTING EXTENSION AND ADDRESSING ELECTRONIC SERVICE**

This Order addresses the request filed by Commission Staff on March 24, 2020, for an extension of the deadline to file its recommendation. Polonia WSC and Lockhart have not made the filing required by Order No. 1 clarifying whether they wish for the application to proceed under Texas Water Code (TWC) § 13.248 or § 13.301. Polonia WSC and Lockhart need to clarify which section of the TWC they wish to proceed under before Staff can make its recommendation. The administrative law judge grants the extension.

On or before April 8, 2020, applicants must file a clarification regarding whether they intend for the application to proceed under TWC § 13.248 or § 13.301.

On or before April 22, 2020, Commission Staff must file a recommendation regarding the administrative completeness of the application, along with a proposed procedural schedule, if appropriate.

Commission Staff also moved to require service by electronic mail and to direct any party that has not previously provided an email address to file a notice informing the parties of the email address to be used for service. In light of the Commission's Order entered in Docket No. 50664,<sup>1</sup> Commission Staff's request to require electronic service is moot. The ALJ, however, requires any party who has not previously provided an email address for service of documents, to file in this docket no later than April 3, 2020 a notice specifying an email address for service of documents.
