STAFF'S RECOMMENDATION ON SUFFICIENCY OF THE APPLICATION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Staff's Recommendation on Sufficiency of the Application. Staff recommends that the application, as supplemented, is sufficient for further review. In support thereof, Staff shows the following:

I. BACKGROUND

On February 25, 2020, Jivitel, Inc. (Jivitel) filed an application for approval of a SPCOA under PURA¹ §§ 54.151-.159 and 16 Texas Administrative Code (TAC) § 26.111. Specifically, Jivitel's application requests an SPCOA to provide resale telecommunications services throughout the State of Texas. Jivitel filed supplemental information on March 6, 2020, March 19, 2020, and March 25, 2020.

On March 25, 2020, Order No. 3 in this proceeding was issued, requiring Staff to file its recommendation on sufficiency of the application by April 8, 2020. Therefore, this pleading is timely filed.

II. RECOMMENDATION ON SUFFICIENCY

Staff has reviewed the application, as supplemented, and recommends that it is sufficient for further review. This recommendation does not address the merits of the application.

III. CONCLUSION

Staff recommends that the application, as supplemented, is sufficient for further review. Staff respectfully requests that an order be issued consistent with the foregoing recommendation.
