### **COMMISSION STAFF'S REQUEST FOR EXTENSION**

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for Extension. In support thereof, Staff shows the following:

## I. BACKGROUND

On March 10, 2020, Nerro Supply, LLC (Nerro) filed an application for a pass-through rate change. The proposed pass-through rate change affects customers in the Maple Leaf Gardens and Oakland Village subdivisions within the service area for Nerro water certificate of convenience and necessity number 12252. The proposed pass-through rate would increase the pass-through fee from \$4.00 per 1,000 gallons to \$5.00 per 1,000 gallons. The application requested an effective date of April 1, 2020.

On March 12, 2020, Notice Setting the Deadline for Commission Staff Recommendation on the Application and Notice was issued establishing a deadline of April 9, 2020 for Staff to file a recommendation on the application and notice, and propose a procedural schedule, if appropriate. Therefore, this pleading is timely filed.

#### II. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional information from Nerro to recommend approval of the application. Therefore, Staff requests an extension until May 7, 2020 to allow Nerro to provide additional information and Staff to file a recommendation on the application and notice.

### **III. CONCLUSION**

Staff respectfully requests an order consistent with the foregoing request.
