SUPPLEMENT TO THE JOINT PETITION BY THE CITY OF CONROE AND AQUA TEXAS, INC. FOR APPROVAL OF A SERVICE AREA CONTRACT UNDER TEXAS WATER CODE § 13.248 AND TO AMEND WATER CERTIFICATES OF <u>CONVENIENCE AND NECESSITY IN MONTGOMERY COUNTY, TEXAS</u>

COMES NOW, the City of Conroe (Conroe) and Aqua Texas, Inc. (Aqua) (collectively Petitioners), and hereby file this Supplement to the Joint Petition for Approval of a Service Area Contract under Texas Water Code (TWC) § 13.248 and to Amend Water Certificates of Convenience and Necessity (CCNs) in Montgomery County, Texas (Supplement to Petition). In support thereof, Conroe would respectfully show as follows:

I. BACKGROUND

On December 16, 2024, the Petitioners filed a petition at the Public Utility Commission of Texas (Commission) for approval of a service-area contract under Texas Water Code § 13.248 and to amend Conroe's certificate of convenience and necessity (CCN) number 10339 and Aqua Texas's CCN number 13203 in Montgomery County (Petition). Conroe filed supplemental information on December 27, 2024. On January 16, 2025, Commission Staff filed its Recommendation and Memorandum, recommending that the Petition be found Administratively Incomplete. Order No. 2, issued on January 23, 2025, gave Petitioners until February 18, 2025, to cure the deficiencies as described in the January 16, 2025, Memorandum of Jolie Mathis. Therefore, this Supplement to Petition is timely filed.

II. SUPPLEMENT TO PETITION

Petitioners hereby submit the revised maps and shape files to address the deficiencies and issues noted in the January 16, 2025 Staff Memo regarding the Petition. Petitioners have revised

their maps depicting the Transfer Area. Attached hereto as **Exhibit A** are (i) a revised general location map and (ii) a revised detailed location map, all of which identify the requested area to transfer from Aqua Texas, Inc. (CCN No. 13203) to City of Conroe (CCN No. 10339), which includes approximately 4 acres Such new maps and files shall replace the initial maps and shape files included in "Exhibit E" to the Petition filed in Item 1 and Item 3 on December 16 and 27, 2024 in this Docket.

III. CONCLUSION AND PRAYER

For these reasons, the City of Conroe and Aqua Texas, Inc. respectfully request that (1) this Supplement to Petition be deemed properly filed with the Commission; (2) that the Commission approve the Contract as provided under TWC § 13.248 and 16 TAC § 24.253; (3) that the Commission enter an order transferring the requested portion of Aqua Texas, Inc.'s water CCN No. 13203 to the City of Conroe's water CCN No. 10339; and (4) that all other orders, acts, procedures, and relief be granted as are necessary to enforce the Contract.


