Dear Chair Walker and Commissioners:

On behalf of our 2.3 million AARP members in Texas, I am writing to express our support for the "Petition for Emergency Customer Protections Rules" in Docket No. 50664, as filed by Texas Legal Services Center, et al. on March 20, 2020.

As you know, hour by hour, the health and economic fallout of the COVID-19 crisis is growing. With an increasing number of Texans under shelter in place requirements and the arrival of warmer temperatures, utility usage and bills are likely to increase in the coming weeks. Increasing utility demand coupled with the reality that many Texans may be newly out-of-work is creating a dangerous situation for residents of our state. Older Texans are particularly vulnerable to increased utility costs due to fixed incomes and yet must stay home to protect themselves from contracting COVID-19.

The proposal in the petition would prevent electric, water, and phone providers from charging down payments, fees, late charges, or effectuating terminations until 30 days after the state of emergency has been terminated. These protections are important and are in line with previous Public Utility Commission action in the wake of extreme weather events. 2



Without utility service, some Texans face the very real prospect of injury or death. We believe the protections before you will go a long way in preventing such tragedies. Please consider adopting this rule as soon as possible. The welfare of some of our most vulnerable residents may hang in the balance.
