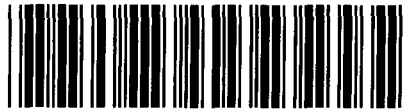

Whispering Ridge Water Rate Increase Proposal

The one water well inside the Whispering Ridge addition in Clifton, Texas services 29 residential homes. There are several swimming pools in the addition, as well as numerous sprinkler systems. My home is on the highest level in the addition. I have 3 outside faucets that are away from my house but, they only drip because of low water pressure. My inside pressure is acceptable, but not great. I would like to see a booster pump installed at the well so all neighbors could receive the optimal pressure. There was only one holding tank by the well for years and then after several episodes of no water in the summer and fall of 2018, a new additional holding tank was added in the summer of 2019. This was done only after so many new homes had come on line in the neighborhood over the last four years. There have still been episodes of no water and a continuing problem of low water pressure to many of the neighbors.

I understand and accept the need for a reasonable rate increase, but I think this rate is above and beyond the need, until regular mandated maintenance (not just a bottle of bleach), water reliability and standardized water pressure are assured to all participants.

There is a stipulation in our neighborhood homeowner's guide that states we cannot drill our own water well, so in other words, Mr. Payne (who by the way, developed the neighborhood) has us all "over the barrel"! We do not have a Homeowner's Association here.
