# SOAH ORDER NO. 5 ADMITTING EVIDENCE AND REMANDING TO COMMISSION

On September 3, 2021, Commission staff, on behalf of all parties, filed a joint motion to admit evidence and remand. The motion is granted.

#### I. ADMITTING EVIDENCE

As requested, the following documents are ADMITTED into evidence for the purpose of supporting and seeking approval of the Agreement:

- (a) the Application of Crystal Clear Water, Inc. (CCWI) for Authority to Change Rates, filed on April 8, 2020;
- (b) Additional Information, filed by CCWI on April 23, 2020;
- (c) CCWI's Revised Water Rate Increase with Attachments, filed on August 19, 2020;
- (d) CCWI's Response to Commission Staff's First Request for Information, filed on April 15, 2021;
- (e) CCWI's Response to Commission Staff's Second Request for Information, filed on April 26, 2021;
- (f) CCWI's First Supplement to Response to Commission Staff's Second Request for Information, filed on May 12, 2021;
- (g) CCWI's Response to Commission Staff's Third Request for Information, filed on May 12, 2021;
- (h) Agreements by Intervenors authorizing and designating (i) Sam Wells as the representative for the Airport water system, (ii) Pat Cauley as the representative for the Glenshores water system and for the Lakeline Acres water system, and (iii) Bryan Bronstad as the representative for the Whispering Ridge water system, Exhibit 1 to the motion;
- (i) Unanimous Stipulation and Settlement Agreement (Agreement), Exhibit 2 to the motion;

- (j) Joint Proposed Final Order (Attachment A to the Agreement), the agreed proposed tariff (Attachment B to the Agreement), and the agreed list of assets (Attachment C to the Agreement); and
- (k) the affidavit of Anna Givens in support of the agreement, filed September 3, 2021.

## II. DISMISSAL AND REMAND

The Agreement is unanimous and resolves all issues in this case. Therefore, this case is DISMISSED from docket of the State Office of Administrative Hearings and REMANDED to the Commission.
