COMMISSION STAFF'S REQUEST FOR EXTENSION

On April 8, 2020, Crystal Clear Water, Inc. (Crystal Clear) filed a Class C Rate Change Application with the Public Utility Commission of Texas (Commission), for service provided in Bosque County under Certificate of Convenience and Necessity (CCN) No. 12997.

On September 15, 2022, the administrative law judge (ALJ) filed Order No. 17, directing parties to file an amended proposed order by October 12, 2022. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff of the Commission (Staff) may request that the time allowed for filing any documents be extended for good cause. Staff is still reviewing and seeking more information about Crystal Clear's application and is not yet ready to file an amended proposed order. Accordingly, Staff respectfully requests that the deadline to file an amended proposed order be extended to November 30, 2022. Staff has conferred with representatives for two of the intervenor groups—the Airport Water System and the Glenshores and Lakeline Acres Water Systems—and is authorized to represent they are unopposed to the proposed extension request. Staff has also conferred with counsel for Crystal Clear, and they have communicated that Crystal Clear is opposed to the extension request. Nevertheless, parties have not reached an agreement on the amended proposed order, so Staff is not prepared to file a joint amended proposed order today.

II. CONCLUSION

For the reasons detailed above, Staff respectfully requests that the deadline to file an amended proposed order be extended to November 30, 2022.

Please note that the representative for the remaining intervenors group, Whispering Ridge Water System, has moved from the subdivision and is no longer representing the subdivision. Whispering Ridge Water System has not yet named a replacement representative.
