AGREED REQUEST TO AMEND PROCEDURAL SCHEDULE

On April 27, 2020, Josephine Fuller, individually and on behalf of the ratepayers of the Windermere Oaks Water Supply Corporation (Petitioners or Ratepayers), filed a petition under Texas Water Code (TWC) § 13.043(b) appealing the decision by Windermere Oaks Water Supply Corporation (Windermere) to change its water and sewer rates. On April 30, 2020, Petitioners filed an amended petition, and on May 27, 2020, Windermere filed its response to the petition.

This docket was referred to the State Office of Administrative Hearings (SOAH) on June 23, 2020. SOAH Order No. 7, filed on February 2, 2021, adopted the parties' proposed procedural schedule. The Staff of the Public Utility Commission of Texas (Staff) now requests, with the agreement of the Ratepayers and Windermere, an amendment to the hearing dates included that procedural schedule.

I. REQUEST TO AMEND PROCEDURAL SCHEDULE

The procedural schedule adopted on February 2, 2021, set the hearing on the merits for the "Week of July 12-16, 2021," for a total of five days. After conferring with Windermere and the Ratepayers, Staff requests that the procedural schedule be amended to set the hearing on the merits for July 14-16, 2021, for a total of three days. Staff is authorized to represent that Windermere and the Ratepayers are in agreement with this request.

II. CONCLUSION

Staff respectfully requests that the procedural schedule be amended and that the hearing on the merits be scheduled for July 14-16, 2021.
