**RATEPAYERS’ REQUIRED FILING PURSUANT TO SOAH ORDER NO. 19**

TO THE HONORABLE CHRISTIAAN SIANO AND DANIEL WISEMAN,  
ADMINISTRATIVE LAW JUDGES:

THE REPRESENTATIVES OF THE RATEPAYERS OF WINDERMERE OAKS WATER SUPPLY CORPORATION (“Ratepayers”) file this their Required Filing Pursuant to SOAH Order No. 19 and would show as follows.

1. This Required Filing is timely as it is filed within the deadline set forth in SOAH Order No. 19.
2. Ratepayers’ counsel has conferred with counsel for Windermere Oaks Water Supply Corporation (“Windermere”) and with counsel for PUC Staff. The parties are not in agreement on how to proceed. Accordingly, Ratepayers submit this proposal for the ALJs’ consideration.
3. Ratepayers propose that on remand: (i) the evidentiary record be reopened; (ii) Windermere’s objections to discovery and to hearing evidence be overruled in light of the Commission’s order of remand; and (iii) Ratepayers be permitted to amend their pleadings herein to address matters the ALJs have now determined Ratepayers are required to plead and prove.

4. Ratepayers are prepared to participate fully in any prehearing conference the ALJs determine is warranted in these circumstances.

WHEREFORE, Ratepayers respectfully request that this proceeding move forward as aforesaid and that they receive such other and further relief, at law or in equity, to which they may show themselves justly entitled.
